### 2.1. DRUG PROGRAMS

### 2.1.1. Effectiveness of Programs

- Drug Awareness/Ed. Program For Parents (36.5\% deemed effective)
- Program For Students With An A\&D Problem (26.9\% deemed effective)
- Teacher Training Programs For Drug Prevention (26.5\% deemed effective)
- Support Group For A\&D Recovering Students (20.8\% deemed effective)


### 2.1.2. Less Known Programs

The effectiveness of the following school drug and alcohol programs was not known by a majority (more than $50 \%$ ) of your personnel. The percentages who did not know the effectivemess of these programs reflect the percentages of personnel who either failed to respond or responded Don't Know to questionnaire items A through I of section VI.

### 2.2. SAFETY IN THE WORKPLACE

$78.3 \%$ of the faculty said their workplace is safe, while $21.7 \%$ said their workplace is not safe. Personnel in this latter group gave the following reasons why they consider their workplace unsafe:

- Rules Being Unclear Or Not Enforced (63.9\%)
- Students Being More Violent Than In The Past (62.0\%)
- Outsiders Coming Into The School (43.9\%)
- Alcohol And/Or Drug Use By Students (30.8\%)
- Drug Dealing By Students (24.0\%)
- Students Who Carry Weapons (18.2\%)
- Lack Of Cooperation When Police Are Called (7.7\%)


### 2.3. DRUG POLICY

### 2.3.1. Knowledge of School Drug Policy

The following percentages of faculty agreed with these statements:
School personnel know that information which is life threatening must be disclosed - 79.9\%
School personnel know how to get help from outside the school for students who use alcohol and drugs - 61.3\%

School personnel understand the school drug policy - 65.4\%
School personnel know the consequences of student drug use - $60.6 \%$

### 2.3.2. Compliance With School Drug Policy

The following percentages of faculty agreed with these statements:
School personnel always report students whom they suspect of using or dealing drugs - 53.5\%
The school policy on drugs is applied fairly - 52.3\% - and consistently - 45.5\%
Strict enforcement of policy has minimized our problems - 35.0\%

### 2.4. DRUG USE

- Faculty believed $64.1 \%$ of co-workers used marijuana within the past year.
- Faculty believed $81.9 \%$ of students used marijuana within the past year.
- According to last years PRIDE National Summary, $0.8 \%$ of 4 th- 5 th grade students used marijuana at least once a year, $9.3 \%$ of 6 th-8th grade students used marijuana at least once a year, and $32.3 \%$ of 9 th-12th grade students used marijuana at least once a year.


### 2.5. DRUG INFORMATION QUIZ

The average score on the drug information quiz was $73.2 \%$. This fell below the suggested average score of $77.8 \%$.

The tobacco question most often missed:
Will decrease reaction time (correct response is NO) $53.1 \%$ missed
The alcohol question most often missed:
Is fat soluble (correct response is NO) $47.7 \%$ missed
The marijuana question most often missed:
Is fat soluble (correct response is YES) $\mathbf{7 0 . 1 \%}$ missed
