


The following graphs show the parents' perception of when their child's use of drugs and alochol occurs. Typically, students report that most drug and alcohol use occurs on week nights and weekends.




1.2 - When Does Your Child Use Smokeless Tobacco, Snuff, etc


























CHAPTER 2
